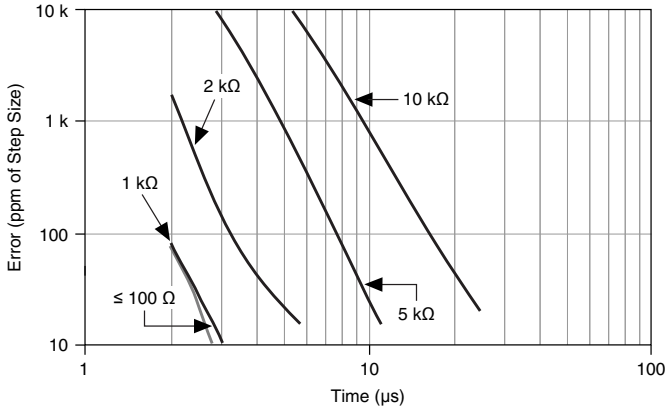

Figure 2. P0.<0..31>: I_{OH} versus V_{OH}

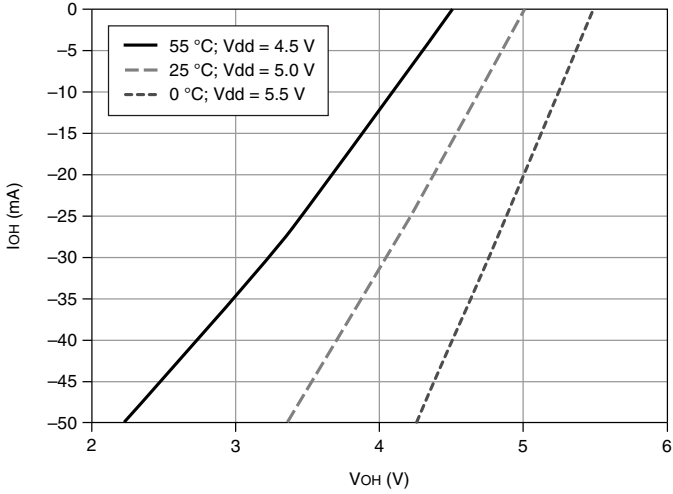


Figure 3. P0.<0..31>: I_{OL} versus V_{OL}

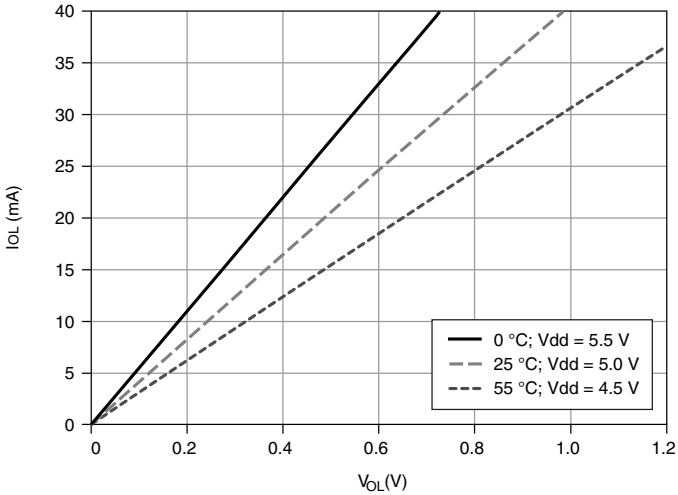


Figure 4. PFI <0..15>/P1/P2: I_{OH} versus V_{OH}

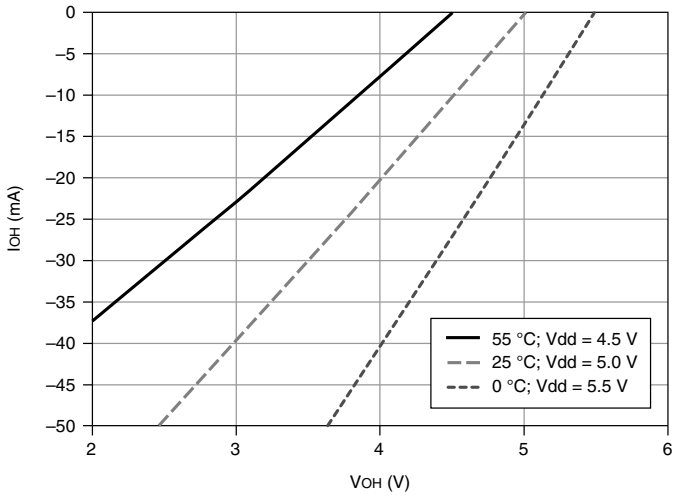
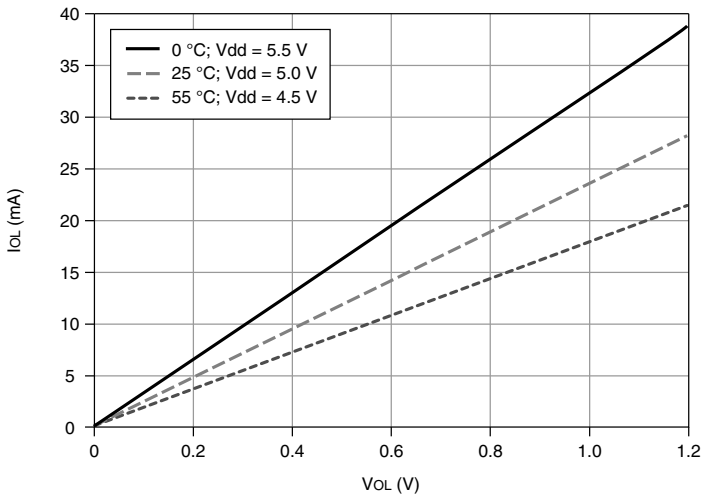


Figure 5. PFI <0..15>/P1/P2: I_{OL} versus V_{OL}
